# COVID-19 PROTOCOLS:



The Event Organizer is requiring fans agree to the terms below prior to ticket purchases & event entry. Please note these confirmations will apply to all members of your party before they are allowed to enter the event and to any users of the tickets purchased by you.

By purchasing tickets for this event, you must confirm that at the time of the event you will have received a negative LAB ADMINISTERED COVID-19 test (generally 48 to 72 hours before the event, HOME TESTS WILL NOT BE ACCEPTED), OR be fully vaccinated against COVID-19 (14 days past final vaccination shot). Children under 12 years of age may be required to take a LAB ADMINISTERED COVID-19 diagnostic test (generally within 48 or 72 hours prior to the event) and provide proof of negative result prior to entering the venue.

Mask wearing will be encouraged. Entry requirements are subject to change. The safety of our guests is our top priority! In accordance with recommendations made by the CDC and local public health authorities, The Dow Event Center and Huntington Event Park has implemented the following policies and procedures to ensure safe and enjoyable events for all guests.

• Masks are welcome at all shows. The CDC and local authorities strongly recommend wearing face masks while indoors regardless of vaccination status. All guests are encouraged to wear masks while attending events at The Dow Event Center and Huntington Event Park.

• Hand sanitizer will be readily available to all guests and staff, including at every entrance and concessions stand. Please remember to wash your hands thoroughly when visiting the restrooms!

• The Dow Event Center and Huntington Event Park will be conducting increased cleaning of high touch surfaces utilizing electrostatic sprayers.



• The Dow Event Center air exchange rate will be increased from normal settings for shows and the disinfection of air handling units will be conducted regularly.

• Please do not enter the facility if you are awaiting the results of a COVID-19 test or are experiencing any of the following symptoms: fever, chills, shortness of breath, cough, fatigue, body aches, sore throat, runny nose or any other symptoms indicating illness.

#### **PROHIBITED ITEMS:**

Below is a partial list of the items prohibited at The Dow Event Center. For a full list, please visit our FAQ page at DowEventCenter.com. In the interest of our guests' safety, the following items may NOT be brought into The Dow Event Center:

• No guns, knives or weapons of any kind including pepper spray, mace and toy/fake weapons

• No bags, briefcases, backpacks or purses larger than 14" x 14" x 6". All bags will be subject to a thorough inspection. Diaper bags will be allowed after thorough inspection if guest is accompanied by child.

- No outside food or beverage items
- No artificial noisemakers
- No large umbrellas small compact umbrellas will be allowed after thorough inspection
- No bottles, cans, glass or liquid containers
- No alcohol or illegal substances
- No aerosol cans
- No animals except service animals
- No laser pointers
